The "Clínica de la Albizu" (CA) Internship Training Program in Clinical Psychology is an exclusively affiliated internship for Albizu University (AU) doctoral students from the Psy.D., and Ph.D. Clinical Psychology Programs. The CA is an outpatient community mental health treatment facility founded in 1966 in affiliation with AU, San Juan Campus. The CA offers a full-time, Doctoral Clinical Psychology Internship to eligible fourth year or higher graduate students enrolled in either the Ph.D. or Psy. D. Clinical Psychology Programs at AU. These programs are APA-accredited clinical psychology doctoral programs.

The internship is a full-time, 12-month experience that consists of the participation in three major programs (general clinical program, domestic violence program, and sexual abused program). This program structure allows interns exposure to diverse clinical experiences and supervisory approaches and styles.
