University, San Juan Campus. The internship is a full-time, 12-month experience and offers three
programs: General Clinic Program, Domestic Violence Program, and Sexual Abuse Program. Interns in
all three programs will offer psychotherapy and assessment. Additionally, interns will work
collaboratively with a senior supervisor and provide weekly supervision to first year graduate students allowing them to
