Dr. Barron joined the PsyD program in April 2020 as the Practicum Coordinator, her specialization is in couple and family systems. She serves on the Domestic Violence Sexual Assault Council of Greater Miami Executive Member, Florida Family Research Network (Bowen) Advisory Board Member, Florida Interest Network Board of the American Association of Marriage and Family Therapists, South Florida Human Trafficking Task Force, Florida National University Powerhouse. Dr. Barron holds clinical memberships in American Association of Marriage and Family Therapists (AAMFT), American Psychological Association (APA) and APA Division 52, International Council of Psychologists (ICP), International Association of Marriage and Family Counselors (IAMFC), Society for Cross Cultural Research (SCCR), and International Violence and Trauma (IVAT). This grant award was in response to the Obama White House "Now is the Time" initiative in response to the Sandy Hook Massacre in Newton, Connecticut. The success of the first grant lead to second HRSA grant award: Behavioral Health Workforce Education and Training (BHWET) Program Integrated training for Healthier Communities (ICHC) Program Training for Marriage and Family Therapy, Mental Health Counseling, and School Counseling; Professional track 1.92 million-for-a four-year funding cycle from 2017-2021. Moreover, Dr. Barron developed Part 1 Modules 1-10 of the Inter-Professional Integrated Care Training for Healthier Communities Course.
